

**ORDINANCE NO. 2023-08-02  
CITY OF ST. MARY'S POINT  
WASHINGTON COUNTY, MINNESOTA**

**AN ORDINANCE AMENDING CHAPTER 206 AND CHAPTER 203 OF CITY CODE  
REGARDING  
MAYOR AND COUNCIL COMPENSATION AND PLANNING COMMISSION  
COMPENSATION**

**WHEREAS**, the City of St. Mary's Point pay for City Council members nor Planning Commission members has not been amended in recent years;

**WHEREAS**, the City Council wishes to additionally compensate the Mayor and City Council Members, as well as the Planning Commission Members on a per meeting basis;

**NOW, THEREFORE**, the City Council of the City of St. Mary's Point hereby ordains that the following sections of the City Code are hereby amended and replaced to read and include as follows:

**Section 206.010. Salaries.**

The Mayor of the City of St. Mary's Point shall be paid an annual salary of Two Thousand Three Hundred and 00/100 Dollars (\$2,300.00) per year and each Council Member of the City of St. Mary's Point shall be paid an annual salary of One Thousand Five Hundred and 00/100 Dollars (\$1,500.00) per year.

In addition to the foregoing annual salary, the Mayor and each City Council shall further receive the sum of \$25.00 for each meeting attended on behalf of the City unless the member's meeting attendance is otherwise compensated by another source.

The Mayor and City Council members shall be reimbursed at the rate as approved by the IRS for mileage for travel to and from meetings or events outside of the borders of the City and for the benefit of the City.

**Section 206.020. Frequency.**

The salaries and per meeting payments provided by this Chapter shall be paid annually or more frequently as directed by the City Council.

**Section 203.050. Compensation.**

Members of the Planning Commission shall be compensated for their service to the City on an annual basis as follows: each member of the planning commission shall receive the sum of \$25.00 for each meeting attended on behalf of the City unless the member's meeting attendance is otherwise compensated by another source. Payment shall be made by the City Clerk in a manner or interval convenient to the office of the City Clerk.

EFFECTIVE DATE. This Ordinance shall be in effect from and after its passage and approval by the affirmative vote of a majority of the City Council, publication as required by law, and after the next regular city election following its passage pursuant to Minn. Stat. §415.11, subd. 2.
